• Call to Order

Christina Cavazos called the meeting to order at 4:00 p.m. as Jesus Amaya was attending a conference. Christina Cavazos asked if any of the previous chairs would be willing to preside over today's meeting. Dr. Wendi J.W. Williams volunteered.
