# **Meeting Agenda**

#### Welcome (5 minutes)

#### **Approval of April Minutes (5 minutes)**

• Minutes approval was tabled until a quorum was reached. Joanna Martinez motioned to approve the minutes at 5:06 p.m., seconded by Micah Bailey. The motion carried.

#### **Elections Update (Mark Murray, 5 minutes)**

- No President-Elect candidate.

• Daniel A. Montez explained his rejection of the nomination, citing the need for a "cooling off" period between Presidential terms.
